MEMBERSHIP CHARGING PRIVILEGES

Upon signing this application, I agree to be responsible for the charges incurred by myself or my family. I agree to abide by all rules and regulations now in effect at the Club and any amendments thereto which may be made from time to time. As a member in good standing with the Golf Club, membership shall include charging privileges by member, his/her immediate family members or guests to member's account. Acceptable charges include, but not limited to, tournament fees, event fees, lessons and merchandise from the pro shop. The Undersigned further acknowledges and agrees that past due amounts will accrue a late fee each month in an amount equal to a minimum late fee established by the Golf Club (not to exceed 18% per annum) from the date of the statement until paid in full. The Undersigned acknowledges and agrees that any such delinquency of 30 days or more will result in the suspension and/or termination of the Undersigned's Membership, without refund of the annual dues, initiation fees, or any other amounts previously paid to the Golf Club.

The Undersigned further agrees to pay all reasonable attorneys' fees, investigation fees and other costs incurred in connection with the collection of delinquent accounts. The Undersigned hereby further acknowledges and authorizes the Golf Club to charge any, and all amounts owed to the Golf Club by the Undersigned that are not paid within 30 days past the 10th day of the month in which the statement was mailed to the credit card specified without any additional authorization, approval or signature of the Undersigned.

Statement of Understanding: By signing below, the applicant understands that they can resign their membership by providing the Club 30-days written notice. Furthermore, they understand that they are responsible for all dues and applicable fees during the 30-day notice period in addition to any previously incurred dues or fees yet unpaid.

TERMS AND CONDITIONS

The Annual Golf Membership at the Bay Point Golf Club permits the use of the golf facilities (Nicklaus Course, Driving Range) to all members covered under said Membership upon payment of the required fees. The Individual Golf Membership permits only the Undersigned individual applicant to use the golf facilities at the Golf Club. The Family Membership permits the Undersigned applicant, his/her spouse and their unmarried children who are under the age of twenty-five and either living in the member's home or attending school on a full-time basis to use the golf facilities at the Golf Club.

Membership privileges at the Golf Club do not imply any ownership interest in the Golf Club or other affiliated property or facilities. The Undersigned acknowledges that a Membership at the Golf Club is non-equity, non-proprietary and non-participatory. Membership does not imply any right or privilege to participate in or to administer business policies of the operation or maintenance of the facilities. The Golf Club reserves the right to change the hours of operation, services, activities, rules, conditions, and policies of the Golf Club at any time without notice to membership.

The Undersigned shall be responsible for his/her conduct and the conduct of his/her immediate family members and guests when using the golf facilities. The Undersigned shall be fully responsible for all property damage and all personal injuries that are caused by or to the member, his/her immediate family members and/or guests. The Golf Club shall not be responsible for or liable for any personal injuries and/or property damages occurring at the golf facilities, including but not limited to, those resulting from the actions of others. Each member, immediate family member and guest shall be deemed to assume all risks of personal injury and loss or damage to property resulting from acts of third parties.

Members acknowledge that use of the golf facilities involve certain risks, including, but not limited to, the risk of being struck by golf balls and other objects utilized or located at the golf facility; adverse weather including lightening; and fracturing, twisting, spraining of muscles, joints and limbs on or near the golf courses while participating in any event or activity held on or around the golf facility by the Golf Club. Each member assumes all such risks for themselves, their immediate family members and/or guests and waives any claims of causes of action which they may have against the Golf Club and its owners, directors, officers, shareholders, partners, managers, members, employees, affiliates, representatives, agents, heirs, successors, and assigns, and the family members of any of each, arising out of personal injuries and/or property damages which the Undersigned may have sustained as a result of using the golf facilities or participating in any event or activity held by the Golf Club on or off the golf courses. Such waiver specifically includes, without limitation, any claim or cause of action arising out of or in connection with any act or omission, whether due to negligence or otherwise, of the Golf Club or their owners, directors, officers, shareholders, partners, managers, members, employees, affiliates, representatives, agents, heirs, successors and assigns and the family members of each.
